TERMS OF AGREEMENT:

1. Parties entering into this contract are bound to fulfill the obligations of this agreement unless both parties mutually agree to leave the agreement and its responsibilities.
2. All bookings are secured only through deposits on a first come first served basis.
3. All payments received including deposits are non-refundable.
4. Any late payments are subject to an additional charge of £100 per day.
5. All cancellations must be made in writing to Dr Trish Darji. In the event of cancellation the customer remains liable for full payment.
6. In the rare event of cancellation by Dr Trish Darji, a full refund will be provided including any deposit.
7. The customer agrees to pay for expenses occurred on the day of the event that may have been overlooked such as parking meters and/or congestion charges for all Bollywood Pianist vehicles. Trish Darji agrees to keep these expenses to a minimum.
8. The customer remains liable for any additional hours or services incurred. The overtime rate for services beyond those outlined in this contract is £150 per hour.
9. The customer accepts full financial responsibility for damage or loss of any equipment while at the venue/location of preparation (during service, after delivery and prior to removal) that is caused by the customer, their contractors, agents, or guests at the event.
10. Dr Trish Darji reserves the right to refuse to carry out services if adequate equipment or performance room is not available, or if he experiences any abuse, threats of physical violence, or if his personal health & safety is being jeopardised, as a direct or indirect result of the customer or appointed coordinators/contractors/guests behavior.
11. Where an acoustic or digital piano is provided by us, the customer must ensure the venue allows for Dr Trish Darji to bring his piano and that he has clear and easy access in transporting the piano in and out of the venue.
12. If a piano is provided at the venue it is the customers responsibility to ensure it is fully tuned and in working condition for the performance.
13. Unless otherwise stated in this contract, Dr Trish Darji will arrive 30 minutes prior to the performance time in order to setup. As soon as the performance is finished, he will pack up his equipment and leave. If the client requires him or any of his equipment to be in place for any additional time outside the stated performance timings, this must be agreed in writing within this contract and paid for accordingly.
14. Any specific song requests must be forwarded to Dr Trish Darji at least 4 weeks in advance to allow adequate time to prepare and arrange the music.
